Supervisor Osborn introduced Josh Bennett who is the Project Developer for EDF Renewables North America, grid-scale power. Josh and his team are in the process of developing Columbia Solar. Some points made by Josh were:

- EDF is a "grid-scale" company that has been in business for over 35 years.
- Columbia Solar Project is a proposed 350-megawatt photovoltaic solar energy generation facility which may include approximately 20 MW(80 MWhours) of energy storage in the Towns of Columbia, Winfield & Litchfield.
- System capacity 350 MW/20 MW energy storage
- 450,000 WMh(hour) equivalent to more than 80,000 homes
- On approximately 1,800-1,900 acres
- Project operation is expected to be 39 years.
 - After 39 years, 98% of the solar modules are recyclable,
- New substation connecting to existing 345kV transmission line running through project area.
- May 9th will be a public meeting held at Francescas Banquet Hall in Ilion.
- Construction is planned for 2025 & project to be operational in 2027
- Article 10 has been replaced by 94-c, which is the permitting process, standardized conditions for solar projects to meet. Included but not limited to environmental studies, engineering & design.
- Solar energy is emissions-free power.
 - Modules are made of silicon, copper & aluminum between glass and plastic with an aluminum frame. Modules do not give off any toxins.
- Generally no pesticides or herbicides are used, possibly only around the substation. Utilization of sheep is recommended.
- Facility will be monitored 24/7 365 days per year from the NERC registered operations control center in San Diego California.
- Training of local First Responders will be prior to installation and annually thereafter.
- BESS systems are made out of the same type of batteries you find in mobile telephones, electric vehicles and portable computers.
- Visual Mitigation is typically evergreen trees.
- Decommissioning & Restoration funds are in place through EDF to remove modules
- Agrivoltaics examples of agriculture cohabitating with solar modules:
 - Native Vegetation
 - Sheep Grazing
 - Cattle Grazing
 - Row Cropping
- Economic Impacts
 - Lease payments

- Pilot & Other Tax benefits county, towns, schools & special districts like fire departments.
- Jobs Up to 300 construction jobs & 5 permanent jobs
- Local Impacts subcontractors, equipment suppliers, local vendors, engineering, electrical work, road construction & maintenance, snow removal, beekeepers, sheep farmers.
- Share the Sun Fund up to \$40,000 per year for initial 10 years, run by members
 of the community, donations chosen by local community representatives, funds
 distributed to local civic groups, nonprofits, projects or other beneficial community
 programs.
- Host Community Electricity Benefit \$175,000 per year for the initial 10 years of the project, split between all residential electricity customers in our host towns.
- Community Partnerships & Donations EDFR partners with the local communities to find the most impactful ways to allocate donations.

 - f. August 13 Maine Greenman Angela Davis
 - g. August 21 Pavilion 2 & fields Auto Show Jack Clark
- 2. Proceed with the process to get power & water to the new pavilion. Paul Jones will get quotes.
- 3. Howard Wakefield replaced the USA flags in the park.
- 4. Village would like to have a few community events in the park. Ex. movie night, halloween trunk or treat and possibly other events with food vendors.

CODES/ZONING OFFICER WRITTEN REPORT:

- 1. Codes and Zoning Officer Mike Connors started his position on March 20th, 2022.
 - a. Issued 3 permits
- 2. Mr. Connors received a call from Gailhead Developement who wants to put in a 30 acre solar farm on Burrows Road. They have requested the zoning & codes information.
- 3. Building Permits will now be on orange paper.

1. Mr. Watkins stated that Jamie Christians property on Route 20 is zoned commercial. Mr. Christian is going through the process to build a convenience store.

 - a. Mr. Donley was able to secure \$5,000 to be used for the handicap restroom.

- 2. Emails need to be run through the town's domain.
- 3. Jim Murphy and Sandy Smith signed the agreement between the village and the town for the firetruck. Supervisor Osborn will also sign the agreement.
- 4. Councilwoman Korosec will send the zoning book to Albany to be rewritten.

NEW BUSINESS:

1. Supervisor Osborn met with Amanda Fetcher who emphasized the importance of paying prevailing wages to contractors who contract through the municipality.

There being no further business to come before the Board, Councilman Royce moved to adjourn, seconded by Councilwoman Korosec.
