Business:

- 1) Designate official newspaper – WEST WINFIELD STAR
- 2) Designate official bulletin board – WEST WINFIELD POST OFFICE
- 3) Designate official depository/investments policy - BANK OF COOPERSTOWN. BANK OF UTICA FOR CD'S for the supervisor. NBT for the Clerks taxes & the Court.
- 4) Establish meeting date, time and place – THE TUESDAY ON OR BEFORE THE 15TH OF EACH MONTH AT 7:00PM. TOWN GARAGE.
- 5) Authorize Supervisor and/or Town Clerk to sign checks and make payments
- 6) Establish mileage rates - \$.70 PER MILE
- 7) Establish the powers and duties of the Supervisor – PER TOWN LAW
- 8) Authorize delegates to the town convention – AS NEEDED
- 9) Authorize Highway Superintendent to expend up to \$2,000 without prior approval of the town board.
- 10) Authorize Town Supervisor to pay utility, health insurance, Spectrum and fuel oil bill without prior approval of the town board.
- 11) Adopt a resolution to fix salaries of all elected and appointed town officials and set the hourly rate of all others.
- 12) Make all necessary appointments.
- 13) Oath of office for all newly elected town officials.
