The supervisor's and town clerk's reports for August were audited by the board members present.

The minutes from the Regular Board Meeting held on August 13, 2025, were read and edited by each board member present.

Public Comments:

1. Dale Brown inquired on guidelines for election signs. Board discussed that signs are to be put up 60 days prior to election and taken down two weeks after election.
  
2. Dan Clark - Optimist club would like to put up a roof over the bbq pit area by the small pavilion in the park. Board will discuss more, and Dan will obtain quotes.

Councilman Michael Peo- Discussion on Equipment replacement.

2013 Truck needs new clutch at cost of \$1300.

Will discuss more at next meeting.

Councilwoman Susan Korosec- Per Don Stockbridge, the doors for the bathroom in the park came in and were installed. No more padlocks will have keys. Also, two fans with lights above rafter in pavilion above stage.

Councilwoman Susan Korosec spoke to Lydia from Upper Susquehanna Coalitions regarding their offer to bring 24 2ft tall trees with protective tubs for planting along the river behind pavilions to help slow erosion. Would like to do on September 24<sup>th</sup>.

Councilman Jay Kulczak-suggested a deposit or fee for usage of pavilions.

Town Clerk-Trash Day is set for September 27<sup>th</sup> from 8-11 with shredding available.

Board approved to hire and pay \$1000 to Christian Dipasqua to work on website to switch from .org to .gov.

A motion was made to approve by councilman Michael Peo and seconded by Councilman Jay Kulczak.

The motion was carried unanimously.

Codes: Mike Connors report – 2 permits issued.

Councilwoman Susan Korosec accompanied Mayor Sandy Smith to town of Exeter to listen to discussion on ambulance expense.

The take aways from the discussion is that the Town of Winfield's options are as follows:

- Form an ambulance district

- Contract with Village of Winfield (as it is now)

- Town would pay a usage fee per call.

Discussion ensued and will be discussed further at next meeting.

Councilwoman Susan Korosec and Supervisor William Miller have met and gone over the budget.

The next Winfield town board meeting will be held on October 15<sup>th</sup>, 2025, at 7 p.m.
